To Little Flowers!

"Many things can wait...Our children cannot..." The most formative years of a child's life are from birth to three. However, the long-term effects of exposure to poverty, unemployment, crime, violence, abuse/neglect and drugs can have an adverse effect on a child and lead to major health issues, school related problems and problems in adulthood.

"National research shows that more than 60 percent of American children have been exposed to crime, abuse and violence—many in their own homes. Ten percent of children in the United States have suffered some form of abuse or neglect and 1 in 16 has been victimized sexually."

Little Flowers Early Childhood and Development Center, Inc. (Little Flowers) was established in 2008. The founder is a licensed graduate social worker with over 20 years of providing clinical services to disadvantaged and vulnerable children and adults in the city of Baltimore and over 10 years of experience in early childhood and development.

Little Flowers is located in the Sandtown Winchester community of west Baltimore City. Sandtown is a community that has been plagued by almost every urban ill (poverty,

unemployment, health problems, low student achievement, illiteracy, teen pregnancy,

substance abuse, and more recently, the Freddie Gray Riots, which set the community back

even more.) 50.3% of the families live at or below the poverty limits, 86.8 % of the children

live-in single-family households and 20.7% of the families are unemployed.

Inside Our Classrooms



Infants and toddlers, ages 6 weeks to 3 years old: Little Flowers uses the OUNCE Scale, which is an assessment tool that enables caregivers and families to monitor their child's development, and the Creative curriculum, which is a comprehensive curriculum with a clear organizational structure and a particular focus on routines and experiences. We focus on building social/emotional skills that serve as the foundation for learning and that last a lifetime.



Preschool, ages 3, 4 and 5 years old: Little Flowers uses the Early Learning Assessment, which allows early childhood teachers and careproviders to collect and use assessment information to tailor instruction to the individual needs of each child. Our preschool classrooms use the Creative Curriculum, which is a comprehensive curriculum with a clear organizational structure and a particular focus on routines and experiences. We focus on building social/emotional skills that serve as the foundation for learning and that last a lifetime.



Little Flowers also has two State Funded, Free Pre-K 4 classrooms. Prekindergarten is a program for four-year-old children who are from families that are economically disadvantaged or homeless. The overall goal of prekindergarten is to provide learning experiences to help children develop and maintain the basic skills necessary to be successful in school. The Prekindergarten program provides appropriate experiences that address the needs of young children in the areas of language and literacy, mathematics, social foundations, science, social studies, fine arts, and physical well-being and motor development.

Our Pre-K 4 classrooms use the Children Study Their World (CSW) curriculum. CSW is an early childhood curriculum for 4-year-olds, based on principles of project-based inquiry and driven by evidence-based practices that build teacher capacity and support successful implementation. It consists of eight interdisciplinary, content-rich projects that build upon children's knowledge and increase in complexity. Each project supports children's common understanding of a topic and nurtures their innate sense of curiosity and discovery about their world. CSW was created by the Center for Early Childhood Education and Intervention at the University of Maryland. Funding for CSW was provided through a grant from the Maryland State Department of Education.



Generation Recharge (G.R.A.S.P) is our before, after school, summer and weekend enrichment program for school-age children, ages 4 to 14. G.R.A.S.P operates early morning hours and extended evening hours so that our program provides a safe, nurturing, learning environment that focuses on education, teamwork and leadership skills. Furthermore, G.R.A.S.P. children get the opportunity to explore Theater, Chess, Step, Boxing, Martial Arts, Music, Creative Art, and Science, Technology, Engineering, Math (via the use of a research-based S.T.E.M curriculum).

Dur Mission

Little Flowers Early Childhood and Development Center, Inc. recognizes that children are our future. Therefore, it is our mission to improve the lives of children by employing a holistic approach to education. In doing so, we are committed to promoting growth in our children through quality education and early intervention, enrichment, parent involvement and collaborations. In addition, we see the importance of positioning children where they can be successful by providing them with safe, nurturing and clean learning environment.

Our curriculum is designed to foster the social, emotional, intellectual, and physical needs of the children we serve.

We believe that children need to be actively involved in learning through play, with opportunities to explore, experience and succeed.

Staff development is a central focus of Little Flowers' program, enabling teachers and assistants to provide comprehensive services for children and families and to assist in the ongoing evaluation and improvement of staff as well as the total program.

- Our students are thriving academically and socio-emotionally. Many are successfully performing in public and private schools after leaving Little Flowers.
- Little Flowers is one of few early childhood education programs in the State to earn the Maryland Excels Level 5 distinction; no other program in Sandtown has this recognition.
- We are continuing our efforts to increase our services to ensure we meet the needs of our children in a holistic manner which involves our continued efforts to provide nutrition, mental health, trauma support and high quality, accredited academic content.
- Aggressively working to broaden and improve our development efforts to provide funding for future initiatives. In 2019 we raised \$36,631.85 in charitable gifts.

We cannot lose our momentum! There are opportunities ahead that will allow us to expand our program to other communities in Baltimore City and in doing so have a greater impact on deserving children and families. The time is now, our children cannot wait.

Letter from the Executive Director



Dear Friends,

Thank you for making 2019 yet another remarkable year for Little Flowers! This was a very challenging year as we moved in new directions with strategic planning and funding development and increasing our overall visibility. This year also marked another year of service for the community and to our most precious prize...Our children. Our children are moving on to public and private schools confident and ready to learn, and moreover, with the social emotional skills they need to thrive in school and in life.

As we close our program year, I would like to acknowledge a few program highlights:

- Little Flowers earned the highest level (Level 5) with Maryland Excels Maryland EXCELS is a quality rating and improvement system that awards ratings from 1 to 5 to childcare and early education programs based on nationally recognized standards and best practices.
- Little Flowers was awarded for the 3rd year the Pre-K expansion grant This state-funded grant will expand access to high-quality prekindergarten for three-year and four-year-old from families with household incomes up to 300 percent of Federal Poverty Guidelines (FPG).
- MECU community grant funding

The cash grants assist organizations in producing free-to-the-public special events for the communities and residents they serve. The MECU Neighborhood Event Grants program is supported by presenting sponsor MECU, Baltimore's Credit Union, the Baltimore City Department of Housing & Community Development.

Increased Marketing and Visibility

We hired a Family Service Coordinator, who uses her diverse skills in education, mental health and business to make remarkable improvements in student retention, parent engagement, communication, and enrollment.

Three of our staff were approved for funding through the Child Care Career and Professional Development Fund (CCCPDF) - a tuition assistance program for childcare providers to obtain a college education at participating colleges/universities in Maryland.

Our ongoing goal is increasing our services and trauma-informed approach to education. Focus on data collection and outcomes. Professional and career development. Program stability.

While Little Flowers is growing and making a difference in the lives of the children and families in Sandtown. We still need you!!! I know we can make this possible! Don't stop supporting us, WE NEED YOU! Give us your talents, WE NEED YOU! Help us give our children a chance. WE NEED YOU! 

Financial Report

In 2019, Little Flowers Early Childhood and Development Center Inc. (Little Flowers) employed 32 people. In addition, Little Flowers provided childcare services for over 200 students throughout the year. Extended summer funding of \$57,407 through PreK Expansion allowed Little Flowers to provide services to 4 and 5-year-olds throughout the summer.

2019 was a year of strategic and operational progress that demonstrated Little Flowers' commitment to education, enrichment and early intervention for many children and families.


Our fundraising campaign for 2019 was our most successful as we reached a great amount of donors and with our enhanced marketing materials was able to attract a wider audience.


Little Flowers Early Childhood and Development Center provides serves to children ages 6 weeks to 12 years. Our greatest area of service is for the School Age. Over 60% of our funding comes from the State of Maryland which we are heavily dependent upon to maintain successful daily operations.

We have estimated we need an additional \$100,000 to in order to maintain our Family Services Coordinator and be able to hire a Mental Health Counselor that can provide on-site services. Also, these funds would be utilized for parenting workshops and trainings.


DATA DRIVES OUR PROGRAM

Tuition and Grants in 2019 totaled \$1.1 million.





